## Introduction

This document describes the use of the electronic PDF forms for the Erasmus+ programme **KA201 – Strategic Partnerships for school education**, **KA202 – Strategic Partnerships for vocational education and training**, **KA203 – Strategic Partneships for higher education** and **KA204 – Strategic Partneships for adult education** within programme countries managed by the National Agencies in the Programme Countries.

# Technical requirements and settings needed to use an electronic PDF form

## Adobe Reader and Acrobat Reader DC

The Erasmus+ decentralised actions electronic PDF forms were built using Adobe Forms technology. You need Adobe Reader or Adobe Acrobat Reader DC to use the forms.


In order to be able to properly use an Erasmus+ electronic PDF form you will need to use the following versions of Adobe Reader:

Minimum Adobe Reader version	Adobe Reader 9.3.3 or higher (except Adobe Reader DC version $15.8$ )
Recommended Adobe Reader version	Acrobat Reader DC version 15.20

Adobe Reader and Acrobat Reader DC can be downloaded for free from the internet at the following location:



If you are using Windows 10 this is how the download page should look like:






If you are using a different version than the above mentioned ones you will not be able to properly use the form and will be confronted with the following screen:



## **Incompatible Readers**

Adobe Reader and Acrobat Reader DC are the only accepted readers. If you happen to use another reader such as "Foxit" or Adobe Acrobat X PRO you will not be able to use the electronic PDF form and may even corrupt it as the following message shows:



## **Incompatible Acrobat Reader DC Versions**

The above mentioned <u>Acrobat Reader DC version 15.8</u> released by Adobe on the  $14^{th}$  of July 2015 has introduced several issues with the Erasmus+ PDF forms and <u>must not be used</u>.

If you happen to open one of the electronic PDF forms still using Acrobat Reader DC 15.8 the electronic PDF form will be blocked and you will not be able to fill it in.

If you are still using Acrobat Reader DC 15.8 please make sure that you uninstall it and install instead latest Acrobat Acrobat DC version as explained above.

There are other Acrobar Reader DC Versions that introduce blocking issues with the Erasmus+ PDF forms and <u>must not be used</u>.

## Adobe Reader DC Version 2015.023.20053 Adobe Reader DC Version 2015.006.30279

If you open one of the electronic PDF forms using one of these versions mentioned above will be blocked and you will not be able to fill it in. The following message will be retrieve:



The Acrobat Reader version you are using has known issues with display or calculation of the form data. Please download and install the latest version of Adobe Reader from http://get.adobe.com/reader/

## **Operating Systems**

The above mentioned Adobe Reader and Acrobat Reader DC versions are supported on Microsoft Windows and Apple OS X. Mobile platforms such as iOS, Android, Microsoft Windows RT, Windows Phone and BlackBerry are <u>not</u> supported by the electronic PDF forms.

Please note that Windows XP is no more supported by Microsoft since 8<sup>th</sup> April 2014. This is explained clearly on Microsoft webpage: https://www.microsoft.com/en-us/WindowsForBusiness/end-of-xp-support.

However, it is true that you can easily found on Internet some ways to make some updates to make Adobe Reader working with the PDF forms. If you consider them you must know the exact consequences and weaknesses on your computer and also all potential related legal issues. If you have any doubt or have some legal issues on the solution, we strongly advise you to consider another platform fully supported.

Electronic PDF forms can be opened on Linux platform only with Adobe Reader version 9.1.

Please note that Adobe was providing a native Reader version on Linux until the version 9.5.5 (26/06/2013). This version is no more available on Adobe website. However, different versions of the package are still downloadable on Internet with the procedure to install them. Please note that we strongly discourage you to use these old versions with unknown PDFs as no more security patches are applied on it.


## **Security and Java Script Settings**

When an electronic PDF form is downloaded from the internet for the first time, Adobe Reader and Acrobat Reader will detect that the form has originated from a potentially unsafe location and ask you to confirm the safeness of the file:



On top of what is written above, Adobe Reader and Acrobat Reader uses an enhanced security feature that detects when the electronic PDF form is attempting to connect to the internet. Such situation will happen every time you need to input and validate a PIC (Participant Identification Code, provided to the organisation upon registration in the Participant Portal (see section on "Registering your organisation in the European Commission's Participant Portal" at the end of this document) for a participating organisation, or when you have changed a piece of data that impacts the budget section, such as a distance band in the "Travel" budget section. In both scenarios the electronic PDF form will contact central European Commission servers to fetch the latest data and information. The message displayed by Adobe Reader and Acrobat Reader is as follows:

When confronted with this message you should press button "Options", select "I trust this document always" and, when asked, save the form with the <u>same</u> name. This process is sometimes a bit slow, so just let it finish before proceeding.




## New security feature introduced in the Acrobat Reader DC 15.9

When the user uses Acrobat Reader DC 15.9 for the first time with an electronic PDF form which is not stored in an already trusted folder, Acrobat Reader will prompt the user with a new security question asking if the user trusts the "europa.eu" domain (it could happen on Check PIC, on budget change or on submission).

## IT IS COMPULSORY FOR THE USER TO ANSWER "ALLOW" SO THAT THE DOMAIN "EUROPA.EU" IS A TRUSTED DOMAIN AND THE FORM WORKS PROPERLY.


If by mistake the user answers "Block" on the prompt about the "europa.eu" domain then that answer will be applied to all electronic PDF forms and none will properly work in that specific computer. The expected behaviour of the forms will be to show the following error message every time the domain "europa.eu" needs to be accessed e.g. when checking a PIC or computing budget:



In order to revert the previous decision to block the "europa.eu" domain and make the electronic PDF forms work normally, the user needs to:



1) Access Menu "Edit" -> "Preferences..." or Ctrl + K



2) Choose "Trust Manager" and "Change Settings..." button

4) Finally click on "OK" buttons to apply the changes and close the properties' windows.

After that try to open the electronic PDF form and make sure that this time you choose the option "Allow" when prompted to trust the "europa.eu" domain.



## How to fill an electronic PDF form

This section will guide you through the main aspects to consider when filling an electronic PDF form for applying for a grant under an Erasmus+ action managed by the National Agencies.

## Checking that you have downloaded the correct form

Before you start working on your application and filling in your project's data, it is important that you check that you have the right form for the right field of action, call and round. Page 1 of every electronic PDF form contains this information:

Field "Which field is the most impacted?" will show you the field of action of Strategic Partnerships that the electronic PDF form concerns. Do make sure you are using the right one as your application will not display all fields that apply to your project if you submit it through a different form and may be considered as ineligible as a consequence.

Field "Call" is another important piece of information, as it indicates the year of the Erasmus+ Call for proposals concerned.

Note that you cannot change the content of these three fields. If you find out that you have selected the wrong electronic PDF form, you need to close it and download the correct form from your National Agency's website.



Depending on the objectives and the composition of the Strategic Partnership you will have to select one of the two possibilities as depicted below:

Strategic Partnerships relevant to the field of higher education will not support projects for exchange of good practices. This means that if you choose Strategic Partnerships for Higher Education (KA203) the main objective of the project will be pre-filled with "Development of innovation".

Please be aware that as specified in the Programme Guide, the Strategic Partnerships supporting exchange of good practices will not be able to apply for funding for Intellectual Outputs and Multiplier Events, and can apply for funding for Learning/Teaching/Training Activities.

To that end, by selecting to apply for a Strategic Partnerships supporting exchange of good practices, the eForm will not visualise the Intellectual Outputs and Multiplier Events sections, and will apply limitations on the requested budget for Learning/Teaching/Training Activities.



## **Choosing the correct National Agency**


Another important aspect to take into account is the National Agency to which you want to submit your application. The selection of the National Agency is normally done on page 2 of an electronic PDF form. There you can find a drop-down list with the allowed Erasmus+ National Agencies covering each field of education, training and youth. In the list of values below, each National Agency is identified by a unique code accompanied by the name of the country in the national language:

The information to look for is illustrated in the screen shot below and includes the National Agency code and the fields in which it is active.







The last aspect concerning the field(s) for which a National Agency has been designated is of particular importance as this needs to match the electronic PDF form you have chosen. In order to help you, the electronic PDF forms will only show you the relevant National Agency reference according to the field of education, training and youth that you want to submit your project to.

## Using your PIC in an electronic PDF form

For most actions, all participating organisations should be registered in URF and should use their PIC (Participant Identification Code) when filling-in an e-Form. More information about the PIC you will find here: <u>Participant Portal</u>.

When you and your partner organisations or consortium members have a PIC, you can start using these identifiers in your electronic PDF forms.

The PIC field name is the place where you need to enter your organisation's identification:

After you have entered it, press button "Check PIC" so that the electronic PDF form fetches the organisation's data from the Participant Portal. In other words, you do not need to enter again in the electronic PDF form the organisation data that are already registered in the Participant Portal.

Once you have entered the PIC and the eForm has fetched the relevant information in section D.1., you will also see that part of the information in section D.1.1 has also changed:

In the 2018 PDF Forms the applicants can indicate the type of the organisation as this information is no longer filled in the Participants Portal. Please note that, as the field Type of Organisation is a compulsory one, the applicant cannot leave it empty and should pick one option from the drop-down menu.

## **Mandatory fields**

Mandatory (compulsory) fields are clearly identified in electronic PDF forms through a pink colour as depicted below:

Please provide detailed information about the project activities that you will carry out with the support of the grant requested under the item "Project Management and Implementation".



In both sections of Description of the project and Project management and implementation it is of utmost importance that you provide as detailed information as possible concerning the description of the project and the project activities. These sections is the core element of the application and particular attention should be drawn to them. You should also clearly state the role of each project partner, especially in case you do not plan the production of Intellectual Outputs and the organisation of Multiplier Events.

In section G. Project management and implementation of the application form, you will have to select whether or not your project will include intellectual outputs. If you choose "No" you will only have to provide information on the activities that your project will organise and the methods you intend to use. If you choose "Yes" you will have to provide information about the project activities you will support under the "Project Management and Implementation" budget item and in addition you will have to describe the intellectual output(s) your project will produce.

The budget is one of the most important sections of your electronic PDF form. It is partly completed based on what you have entered before in the content related questions of the form.

## **Completing the Budget**

One of the most important principles of Erasmus+ is the wide use of unit cost based grant items. In the case of unit costs, you do not have to calculate the real cost of expenses, but instead indicate the number of units (number of days or number of participants) for a given grant item; based on that number, the form then calculates automatically the grant amount that <u>can</u> be requested, multiplying the number of units with the unit cost concerned. In order to select the correct distance band, you need to get the distance calculated by the web tool that you can access via this hyperlink:

With this tool you can enter the Origin and Destination cities in two given countries and get the calculation of the distance in one direction. On the basis of this information you have to select the corresponding distance band. If the participant needs to go to a farther city to get to his/her final destination (to reach the airport for example) it is possible to take this city as departure point.

The distance band chosen will determine the grant amount available for that distance, as specified in the Erasmus+ Programme Guide. You only need to enter the distance band: the correct grant amount corresponding to the distance band is completed automatically.

Nota bene: When calculating the actual distance you should fill in only the distance from the place of origin to the place of destination and not both ways. The unit cost is calculated on the basis of one way distance; however, the related grant is a contribution to the expenses for travelling in both directions.







It exists a lot of free online tools to compress big PDF files. You can easily find some of them by searching "compress PDF file" on Internet. So you can use the convenient one with your criteria: using your language, with more or less warranty of confidentiality, etc.

Some PDF tools (other than the Acrobat Reader) have the option to save as "optimized PDF". These tools must not be used with the PDF form.

## DOC/DOCX Word document with image embedded:

Recent version of Microsoft word has an option to compress one selected image or all images of the documents. The place of this option is changing from one version to another, so we cannot explain here how to reach it. Please have a look on your documentation or on Internet for your specific version.

## Scanned documents

Let's look at each of these fields in order to understand their meaning and use:

- → The "Submitted" column indicates if the submission was successful. A "YES" indicates a successful outcome.
- → The "Submission ID" is an identifier returned automatically by the European Commission IT servers that uniquely identifies your specific submission. If you submit again you will get a new identifier.
- → The "Submission Date" is the date and time at which your application was received by the European Commission IT servers. It is therefore specified in Brussels time as will be explained later in this chapter.
